### EXECUTIVE SUMMARY

At its January 31, 2025, meeting, the Committee of Bar Examiners (CBE) approved amendments to the Refund of Fees Policy for Examinations to provide relief to victims of disasters that occur close in time to the administration of a bar examination. Staff are now seeking approval of the policy on behalf of the Board so that it will go into effect immediately and staff may provide refunds of bar examination application fees to the victims of the recent Los Angeles wildfires. To date, at least 20 have requested to withdraw from the February bar exam seeking to take the exam in July instead. Under the current Refund of Fees Policy these applicants are not eligible to receive a full refund because the fires took place more than 30 days before the exam.

### RECOMMENDED ACTION

Staff seeks ratification of the revisions to the Refund of Fees Policy approved by the CBE on August 18, 2023 ([Item III.B.](#)). It has come to staff's attention that the Board has not yet approved the 2023 amendments and accordingly ratification is sought now. In addition, staff seeks approval of CBE's recently adopted policy amendments; together these actions will enable staff to accommodate the refund requests of bar exam applicants who are victims of the Los Angeles fires.
