### OPEN SESSION

#### ROLL CALL

The Board of Trustees meeting was called to order by Chair Stallings. Roll call was taken and a quorum was established.

#### PUBLIC COMMENT

Chair Stallings called for public comment, inquiring as to whether there were person(s) who wished to comment on any agenda item. The following comments were provided to the Board:

1. Ray Hayden:  
Ray Hayden reported positive feedback on the experimental exam, proposed the removal of the written section, and commented on the performance test during the pandemic.
2. Benjamin Kohn:  
Benjamin Kohn expressed concern about the handling of the experimental exam for applicants with disabilities and suggested a makeup exam or extra credit to remedy the disadvantage. Kohn also commented on the pushback from stakeholders against their proposals and urged for reconsideration.
3. Erin Schroeder:  
Erin Schroeder discussed their experience with incurring a fee for CTAPP noncompliance and encouraged the adoption of a rule that would allow for the expungement or screening of administrative inactive enrollments.
4. Antonio Hernandez:

Antonio Hernandez, the director for the Lawyer Referral Information Service (LRIS) program for San Francisco Marine at the Bar Association of San Francisco, addressed the proposed increase in recertification fees for LRIS programs, acknowledged the need for sufficient funding for the office compliance to operate, and suggested consideration for a tax on Google ads to bridge the financial gap experienced by LRIS programs.
