- Recognized by the US Department of Education
- National and international scope
- Federal financial aid gatekeeper
- 215 accredited institutions

WASC Senior College and University Commission

Key characteristics of WSCUC accredited institutions:

- **Quality**
- **Financial and educational sustainability**
- **Focus on student success**
- **Data-driven: regularly generate, evaluate and make public student achievement data (retention, graduation, and licensure pass rates)**
- **Commitment to continuous improvement**
