OPEN SESSION

ROLL CALL

The Board of Trustees meeting was called to order by Chair Stallings. Roll call was taken and a quorum was established.

PUBLIC COMMENT

Chair Stallings called for public comment, inquiring as to whether there were person(s) who wished to comment on any agenda item. The following comments were provided to the Board:

1. Todd Hill:
This speaker criticized the State Bar's lack of transparency, citing delays in responding to Public Records Act requests and exemptions from oversight. They urged the Board to prioritize accountability to restore public trust.
2. Ray Hayden, JD:
This speaker called for removing the written section of the California Bar Exam, arguing that multiple-choice questions better assess competency. They emphasized that real-world legal practice relies on reference materials, not memorization.
3. Benjamin Kohn:
This speaker raised concerns about denied testing accommodations, citing vague explanations and holiday-season delays that deter appeals. They urged the Board to address these systemic barriers.
4. Rianne Pacheco (Legal Aid Association of California):

This speaker supported agenda item 3.3 and expressed concerns that remote bar exams increase costs and logistical challenges, disproportionately impacting low-income and diverse candidates.

5. Anonymous Caller:

This speaker requested an extension for bar exam registration, citing financial hardship and missed deadlines. They argued that remote testing eliminates the need for strict early registration.

6. Claire Solot (Legal Services Funders Network):

This speaker supported agenda item 3.3 and highlighted financial barriers in the bar exam process. They urged the Board to address cost-related inequities affecting future public interest attorneys.
